INFORMATION CLAUSE

For participants of the Project "Raising the competences of academic staff and the institution's potential in accepting people from abroad – Welcome to Poland"

According to Art. 13 items 1 and 2 of Regulation (EU) No. 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal EU L 119 of May 4, 2016, p. 1), further called "RODO", National Academic Exchange Agency having it's headquarter at 40 Polna Street, 00-635 Warsaw, inform that:

- 1. You can contact the Data Protection Officer in all matters regarding the processing of personal data and the exercise of rights related to data processing. The administrator entrusted the processing of your personal data, based on the concluded agreement regarding co-financing the project, to the National Academic Exchange Agency. - 3. The processing of my personal data under the Operational Programme Knowledge Education and Development 2014-2020 is based on the grounds of Art. 6 item 1 point c and Art. 9 item 2 point g of RODO Regulation (EU) No. 1303/2013 of the European Parliament and of the Council of December 12, 2013 establishing common rules on the









European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development and the European Maritime and Fisheries Fund and laying down general provisions on the European Regional Development Fund, The European Social Fund, The Cohesion Fund and the European Maritime and Fisheries Fund as well as repealing Council (EC) No. 1083/2006 (Official Journal EU L 347 of December 20, 2013, p. 320, as amended); - Regulation (EC) No. 1304/2013 of the European Parliament and of the Council of December 17, 2013 on the European Social Fund and repealing Regulation (EC) No. 1081/2006 (Official Journal EU L 2013.347.470) and Appendix No. I and No. II to this Regulation; -Commission Implementing Regulation (EU) No. 1011/2014 of September 22, 2014 establishing detailed rules for the implementation of Regulation (EU) No. 1303/2013 of the European Parliament and of the Council with reference to the templates for the transmission of certain information to the Commission and detailed rules for the exchange of information between the beneficiaries and managing, certifying, audit and intermediary institutions (Official Journal EU L 286 of September 30, 2014, p. 1); - the Act of July 11, 2014 on the principles of implementation of programmes in the area of cohesion policy financed in 2014-2020.

- 4. Your personal data will be processed solely for the purpose of implementing the project, in particular confirmation of eligibility of expenditure, provision of support, monitoring, evaluation, control, audit and reporting as well as information and promotion activities under Operational Programme Knowledge Education and Development 2014-2020.
- 5. Providing personal data is prerequisite for implementing the purpose specified in item 4. The consequences of not providing personal data arise from the legal regulation, including eliminating from the participation in the project processed under the Operational Programme Knowledge Education and Development 2014-2020.
- 6. Your personal data has been entrusted to the Intermediate Authority The National Centre for Research and Development, having it's headquarter at 47a Nowogrodzka Street, 00-695 Warsaw, to the beneficiary implementing the project National Academic Exchange Agency, having it's headquarter at 40 Polna Street, 00-635 Warsaw and entities which, at the request of the beneficiary, participate in the implementation of the project (entities responsible for registration of the participants and entities preparing conference materials). Your personal data may also be entrusted to specialist companies implementing, at the request of the Managing Authority, the Intermediate Body and the beneficiary, inspections and audits under the Operational Programme Knowledge Education and Development 2014-2020.
- 7. Your personal data may be disclosed to authorized bodies in accordance with applicable law.









- 8. The data will be stored for the period necessary to implement the purpose specified in item 4, until the obligation to store data resulting from legal regulation expires.
- 9. Due to the processing of your personal data, you are entitled to demand an access to your personal data, rectify it, delete or limit processing.
- 10. If you become aware of an unlawful data processing, you also have the right to lodge a complaint with the supervisory body dealing with the protection of personal data, whom is the President of Personal Data Protection Office.
- 11. Your personal data will not be the subject of automated decision making and they will not be profiled.
- 12. Your personal data will not be transferred to third parties.
